And both of them look quite old. One west facing by the tennis courts and the other south facing one by the allotments. That's it! So on a nice day (especially during social distancing times) if one person was sat on one bench and one on the other then there is nowhere else for people to sit and enjoy the greenspace. There aren't even any picnic tables for families to sit down at.

There are picnic tables and benches in the kids play area, but as a single man with no kids, I don't think it's appropriate for me to go and sit in there by myself, and I'm not the only person in Four Marks without kids.

Are there any plans to put some more benches or even picnic tables at the rec? Anything planned to celebrate the Queen's jubilee, or at any point the future? I think people would quite like to sit and enjoy one of the few public greenspaces we have in Four Marks, especially around the cricket pitch area. It would be lovely to have benches all around there, rather than just the 2 which are in one corner by the allotments and tennis courts.

I would be interested to hear if there are any plans.

Agenda item 9.3

The NALC webinar on 'Fighting Climate Change' was informative and really focused on the meaningful impact that Parish and Town Councils can have despite them often feeling powerless to make significant change with only 30% of local Parish Councils having declared a climate emergency.

The session will be available to view as it was recorded and will be circulated should Councillors wish to view. There were several engaging speakers including one from Friends of the Earth and Kendal Town Council. Various initiatives were discussed including making information on insulation and solar panels available by engaging residents who have invested in these initiatives to share their experiences with others, trying to encourage a modal shift by car sharing, using public transport and walking/bike riding and also introducing a community share project. Salisbury Town Council were used as a successful example of this where residents are able to share items ranging from power tools to books.

A wide range of resources were discussed that could influence the types of projects that the Council underakes and these will be available via links on the pack that is due to come out. Two that I found of particular interest were a new Parish Online layer which includes information on the energy efficiency of homes in Four Marks and also a tool to calculate the carbon footprint of the area (which I have attached here). This allows a comparison between Four Marks, East Hampshire and the national profile.

It is suggested that the Committee reviews the Climate and Nature Emergency Action Plan at the next meeting or that a separate group is formed to look at environmental issues and potentially oversee the Greening Campaign which could feature some of the ideas from the webinar.
