I hope you are well.

I am writing to you to you in your capacity as Clerk at Four Marks Parish Council to introduce Metis Homes.

Metis Homes controls a parcel of land to the rear of 131 Winchester Road, Four Marks, outlined in red and numbered 16 on the attached plan, which is proposed for inclusion within the Four Marks settlement boundary in the emerging East Hants Local Plan. Metis Homes has been engaging with officers at East Hants District Council and Hampshire County Council extensively through a formal preapplication process, and later this year will be consulting on its emerging proposals for a development including much-needed market and affordable housing.

If approved, as well as delivering housing at a site proposed to sit within the settlement boundary to help meet the needs of the district, the proposals will also provide a significant contribution to local infrastructure, as required by all new development, to areas such as roads, schools, healthcare, green spaces and community facilities.

As part of its commitment to engage with the local community and deliver a scheme that benefits the area, Metis Homes has appointed Luminate Consultancy - a specialist in community and stakeholder engagement – to consult with local representatives and the wider community, in order to understand local views and refine its proposals accordingly. As part of this commitment, a formal public consultation exercise will be carried out later this year.

We are keen to discuss the proposals in more detail, and, if I may, my colleague or I will contact you in the coming days in the hope we can arrange a convenient time and date to meet.
