# 25.17.01 To receive update on Neighbourhood Plan and drop-in sessions.

The Neighbourhood Plan (NP) steering group had applied for and received a technical support grant from Locality. However, there was a delay in using all the funding by the deadline (end of the financial year) and a proportion has been returned to Locality. The consultants are to be paid from that grant. That remaining sum may be re-applied for but applications are delayed.

Two pieces of work are ongoing – the Housing Needs Assessment has been delayed - the first "kick-off" meeting was last week. And, the Site Option Assessment which will look at all available sites re their suitability for development – there are 70 sits for evaluation. The date of the next consultation has been moved to September.
