The following is an excerpt from Alton Town Council's Open Space policy regarding food trucks:

ATC will permit the use of their open spaces by street vendors where they can demonstrate that they are carbon neutral. This means, where vehicles or trailers are used for trading purposes, they must not use generators, gas stoves/ovens or keep their engines running (idling). Where vendors are permitted to trade, they will be charged a flat rate of £50 per week regardless of trading times, which will be limited to between the hours of 9am and 6pm each day. Vendors are requested to trade from hardstanding areas wherever possible to avoid damage to grass but must ensure they do not obstruct the use of parking bays or footways. All litter associated with their trade must be removed from site otherwise a charge of £50 will be made for every occasion

when the ATC grounds team has to clean up afterwards. Vendors trade at their own risk, and must ensure they carry adequate insurance and all required health and safety and food hygiene certification for their business. This policy will become mandatory from 1st April 2025 for all vendors including those at ATC hosted events and those operated by third parties, with a specific exemption for the Funfair and Circus at the Butts given the nature of their activities. Until such time as this section of the policy comes into effect, traders are requested to seek to minimise the use of generators and diesel engines wherever possible.

Email from resident -

I enclose photos of the three bin areas which were badly affected by bramble / nettles. These areas have all now been cleared, properly.







Suggestion: we need to put down some 'hard-standing' underneath these three bins ASAP to finish the job. This will:

- [a] drastically limit future bramble and nettle growth
- [2] make it much easier to get rid of any growth which does intrude into the space
- [3] improve year-round access for dog owners, the vast majority of whom are being very responsible

Hard-standing could be very cheap to do; use 4 cheap paving slabs to surround the three bin posts. If you advertise on social media, somebody in the village might provide for free. (I can advertise if you wish). Lots of people have spares or second-hand hanging around, getting rid of them is expensive at the tip. Preferably 600×600 , but the more normal 450×450 might do at a pinch. Even at Wickes prices:: Twelve 600×600 slabs are only £108. Peanuts. Both types are in stock at ALTON. They do however deliver. I do not at present have a suitable car for this type of transport.

Then all we need is some wet weather, softer ground, and the PC gardener could put them down? 95% of the difficult work is already done.

I can diamond cut any cut-outs needed in slabs if your people can't do it. See image. Can do this at my place IF the slabs are delivered to me AND collected, OR I can do it while Victoria is at the Office for a few hours and can provide me with 240V if slabs are close to PC office. That might be easier. I will do diamond cutting free of charge.

What I need now is agreement from you / PC that cheap and easy hard-standing is the way forward. It will drastically reduce maintenance in the future, and will provide a far better experience for the village's highly co-operative dog owners throughout the year.

If you agree, do you want to advertise for slabs on social media or would you prefer me to?? Or simply get somebody to go to Wickes / or use delivery?
